

Despite being the shortest month to account for activity in the real estate market, February made a great showing on the PTC Index at 351 points.

To start, building permits 26 percent from January and fell slightly by 31 percent versus a year ago. New home sales, however, posted an exceptional 16 percent increase from January and a near 21 percent increase from a year ago.

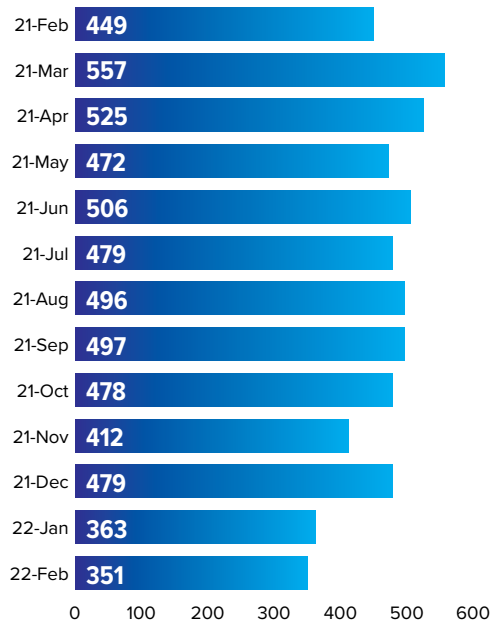
Existing Homes sales remained steady from January to February and are up an incredible 64 percent from last year. With the rise in mortgage rates, refinance activity again dipped 12 percent since January with a total of 1,626 filings for the month versus 3,625 filings from this time last year.

Finally, the average sales price for homes in the Treasure Valley is \$571,761, a near four percent increase from last month. Ada County's average sales price was \$649,378 and Canyon's at \$494,144.
